2024 Recipient Mare Contract

ICSI – Embryo Transfer

ProFuture Equine Reproduction, hereafter known as PF, agrees to guarantee a recipient mare for the transfer of fresh or frozen/vitrified embryos or embryos produced from ICSI from the donor mare listed below for the calendar year of ____.

By entering into this contract, the embryo owner agrees to the following charges when those charges are applicable:

1. \$1,600.00 - Non-Refundable/Non-Transferable Contract Deposit
 - i. Will be credited back onto owners account when the recipient mare has been returned to ProFuture Equine (non-transferable to another owner)
2. \$500.00 - Embryo Transfer Fee (per embryo)
3. \$5,000.00 - Recipient Mare Lease Fee
4. \$15/day – Recipient Mare boarding and maintenance fees up to 120 days of gestation
 - a. Only applied when mare has reached 45 days of pregnancy but will be retroactive back to the date of 25 days of gestation.

ProFuture has chosen to separate charges instead of “packaging” them. Separating the charges allows billing and veterinary work to be transparent to you as a client. PF has found that “packaging” charges does not allow such transparency and acts to penalize a client’s fertile donor mare at the expense of another client’s sub-fertile donor mare. ProFuture’s goal is to offer industry leading work for an affordable and competitive rate.

By entering into this contract, the embryo owner acknowledges and agrees to the following:

1. To pay ProFuture Equine sixteen hundred dollars (\$1,600) **NON-REFUNDABLE/NON-TRANSFERABLE** (can be transferred to another donor mare but cannot be transferred to another owner) under any circumstance (regardless of transfer outcome, expiration of breeding season) recipient mare deposit fee that secures a recipient mare for the donor mare whose name appears above for the ____ breeding season only. This deposit fee will be credited to your account and can be rolled over to the following calendar year in the discretion of PF based on circumstances. This fee will be due upon submission of this contract and will secure one recipient mare for the ____ breeding season. This fee not only secures such recipient mare for the owner but also covers expenses including proper care and reproductive management, initial pregnancy exams, the care and medications immediately following the embryo transfer, and up to 20 days of pregnancy. This allows us to offer the highest chance for the recipient to successfully catch the pregnancy. These fees do not include the breeding management and insemination

of donor mares, medications, or the actual embryo transfer fee. Please refer to the attached fee schedule for these fees. Initial _____

If a different owner/lessee wishes to harvest embryos or oocytes from the donor mare identified in this contract, the new owner/lessee must submit a NEW recipient mare contract with ProFuture Equine.

ProFuture Equine must have a completed, signed recipient mare contract and the funds received for said contract before any embryos will be transferred.

THERE WILL BE NO EXCEPTIONS TO THIS.

- 1A. **Recipient Lease Fees:** For each pregnancy recipient mare checked in foal at 45 days with a heartbeat, a lease fee of five thousand dollars (\$5,000) will be due.
 - 1B. **Refunds:** The lease fee will be refunded in full if the mare is no longer in foal prior to 60 days of pregnancy and pending the return of the recipient mare to ProFuture Equine. If the recipient mare aborts between 60 and 310 days of gestation ProFuture Equine will grant a CREDIT of twenty five hundred dollars (\$2,500) upon a written statement from the attending veterinarian stating the mare is no longer in foal. This credit can be used for services of your choice, but will not be refunded.
 - 1C. **Twins:** If the recipient mare is checked in foal with twins the embryo owner must make a decision whether to terminate the pregnancy by day 45 of embryo owner. If embryo owner chooses to terminate the pregnancy ProFuture will consider this a loss of pregnancy and the embryo owner will receive another recipient mare. If embryo owner chooses not to terminate the pregnancy by day 45 of embryo owner, the embryo owner will then have to purchase the recipient mare by forfeiting the one thousand six hundred dollar deposit (\$1,600) and will not receive a credit for this recipient mare. Initial _____
2. The embryo owner agrees to pay all veterinary or miscellaneous fees associated with the care of the pregnant recipient after first positive pregnancy check through weaning of the foal and return of the recipient mare. Recipient mares will be selected for the donor mare based upon reproductive soundness and synchrony with the donor mare's reproductive cycle. ProFuture Equine shall not be held responsible for uncontrollable circumstances pertaining to recipient mares, including but not limited to poor colostrum quality, insufficient milk production, development of placentitis, red bag deliveries, and foal rejection. ProFuture Equine shall not be held responsible for issues arising from improper management of the recipient mare while in the care of the embryo owner (ex: unattended foaling, turnout in areas with insufficient/unsafe fencing, etc.). It should also be understood that each recipient mare has personality traits unique to that individual, and as such, should be managed appropriately to ensure the well-being of the recipient mare herself in addition to the foal. 3. The embryo owner agrees to pay \$15 per day board and all fees associated with routine care of the recipient mare after she has hit 25 days of gestation including weekly progesterone shots and administration fees through 120 of gestation (pending sufficient progesterone levels present) After 120 days of gestation daily board will change to \$20 per day. At ProFuture Equine we believe that ICSI embryo transfer recipients are safely in foal at 45 days and are ready to ship home. If you choose, your recipient mare may be boarded and foaled out at ProFuture Equine for additional fees. Initial _____
4. If at any time ProFuture Equine determines, in its sole judgment and discretion, that the recipient mare needs to be transferred to Interstate Equine Hospital or Oakridge Equine Hospital for medical or surgical treatment, the embryo owner is responsible for all charges. ProFuture Equine will make reasonable efforts to contact the owner in the event that such transfer is required; however, if owner cannot be immediately reached, owner hereby authorizes ProFuture Equine to initiate such transfer, care and treatment. 5. All Recipient mares are the property of PF - Return of Recipient Mare: To return the recipient mare to PF in good health (this includes reasonable body condition) after she has weaned the foal. Once returned and a ProFuture Equine employee has inspected recipient mare to ensure she is in good condition, a credit of sixteen hundred dollars (\$1,600) will be credited to owner's account. ALL RECIPIENTS MUST BE RETURNED UPON WEANING THE FOAL. If the recipient mares are not returned by December 31st of foaling year you will be charged an additional \$1,600. Initial _____
6. It is specifically understood and agreed between the parties that prior to the transporting of the recipient mare(s) from ProFuture Equine, all charges for services rendered in the contract shall be paid in full. NO RECIPIENT MARE(S) SHALL BE RELEASED WITHOUT PAYMENT IN FULL. SUFFICIENT NOTICE (48 HOURS) MUST BE RECEIVED BY PROFUTURE EQUINE TO RELEASE ANY MARES, DONOR OR RECIPIENT IN ORDER TO ENSURE THE PROPER PAPERWORK IS PREPARED FOR SHIPMENT. Owner is required to make all shipping arrangements for recipient mare(s) to leave or enter ProFuture Equine between the hours of 8am and 5pm Monday through Saturday, unless previous arrangements have been made well in advance.
7. The embryo owner is responsible for any insurance desired on pregnant recipient mare.
8. ProFuture Equine reserves the right to discontinue service at its discretion and to terminate this contract at any point during the course of the season, upon which the owner will be notified immediately.
9. Any shipped in embryos that arrive at ProFuture Equine facility later than 7:00pm will receive a \$250 after-hours embryo transfer charge. Initial _____

GOVERNING LAW AND VENUE. This Agreement/Contract shall be governed, construed and interpreted by, through and under the Laws of the State of Oklahoma. The parties further agree that the venue for any and all disputes related to this Agreement/Contract shall be in the District Court of McClain County, Oklahoma
